COMPANY PROFILE AND ORGANISATIONAL STRUCTURE

*AGORA' 2000 is a consulting firm established in Rome in 1987. In the cities of ancient Greece, *αγορα* was the market place and the social and economic heart of the community. The Company's name, AGORA' 2000, was selected to underline its aspiration to become a modern "centre of excellence", an intellectual and professional meeting point for international experts sharing common views vis-à-vis the theoretical and methodological approaches to **Economic Development.***

INTRODUCTION

AGORA' 2000 was set up as a traditional European *Bureau d'Etudes*, a centre for the implementation of studies in applied economics, geared to support the formulation and analysis of public and private investment decisions. Since its establishment in 1987, the Company has maintained its commitment for research, innovation, quality and excellence. Therefore, its field of action has now progressively expanded towards technical assistance services in favour of public and private institutions; management, and implementation of complex projects; monitoring and evaluation, as well as training activities.

SECTORS OF ACTIVITY

Over the past twenty-two years of activity, AGORA' 2000 has successfully carried out several assignments in support of economic development both in Europe, and in most regions of the ACP world, the Mediterranean and Middle East, as well as in Latin America, reaching a high rank of specialisation and reputation throughout Europe, particularly in the following areas of intervention:

- Private sector development, industrial and cluster development, trade development;
- Investment promotion and business development, namely in support of SMEs;
- Capacity building of public and private institutions for policy development, regulatory impact assessment, upgrading of the enabling environment, and enhanced provision of economic development services.
- Education and training.

- Studies at all levels of the programme or project cycle (programming, identification, appraisal, monitoring and evaluation);
